VACATION HOUSE CHECK INFORMATION & FORM

PURPOSE: This service is provided by Bedford Township thru the Ordinance Department. Officers from the Ordinance Department will make exterior checks of your residence while you are gone. These checks will be at random so no pattern developed. This program is designed to help residents in Bedford Township who are gone for more than two weeks at a time or reside in other states during the months of NOVEMBER thru MARCH of the following year. Currently there is no cost for this service.

OBJECTIVE: This program is designed to add additional security to our residents who are out of town for an extended period of time during the months listed above. It is NOT a replacement for our current LAW ENFORCEMENT in the Township of Bedford. If an Ordinance Officer discovers any type of criminal activity during an inspection, LAW ENFORCEMENT along with the EMERGENCY CONTACT will be notified along with the HOMEOWNER. For matters not of a criminal nature the emergency contact and homeowner will be notified.
